The parent or guardian by signing below does hereby agree to INDEMNIFY and hold harmless the NWAL and its officers, directors, coaches, representatives, and volunteers and sponsoring swim club from any liability which may incur to the participant, however arising and whether caused by the negligent or intentional acts of the NWAL, its officers, directors, coaches, representatives, volunteers, or the sponsoring swim club.

Community Association Indemnity and Hold Harmless Agreement

I/we (parents) _____ am/are the parent(s) or legal guardians of _____ (here after referred to as "child", whether one or more) and have full authority to execute this indemnity and Hold Harmless Agreement respecting our child's use of the Elm Grove, Sherwood Trails, Hunter's Ridge, and/or any pool the Village Otters deem necessary to use for practices and/or swim meets. We agree as follows:

We agree to indemnify and hold harmless Elm Grove Village Community Association, Inc.; the Hunters' Ridge Village Community Association, Inc.; the Sherwood Trails Village Community Association, Inc.; or any other community or club association; their agents, servants, directors, and employees from all suits, actions, claims, demands, attorney's fees, liabilities, or damages of any kind, character, type, description, arising from, occasioned by, or attributed to, directly or indirectly, any injury to our child occurring on the premises.

The Associations will have no responsibilities whatsoever for the care, safety, supervision, and training of our child and shall have no duty to provide lifeguards or lifesaving equipment during the use of the pools by our child as a member of the Village Otters Swim team and the inspection of the pool premises for dangerous conditions prior to each use is assumed by the parents and the Village Otters Swim team. We understand and agree that the Associations' grant of permission to our child to enter upon the pool premises and utilize the pool premises as a member of the Village Otters Swim Team is expressly conditioned upon such assumption of full responsibility by the Village Otters Swim Team and us.
